Jr. Miss Gila River Eligibility Criteria

Young women between the ages of 14-17 years of age on or before **February 25, 2022**

Enrolled member of the Gila River Indian Community

Have never before held the Title of Jr. Miss Gila River

Must be a full-time student with a minimum 2.0 G.P.A.

Must be single, never married, and have no children

Must not be cohabitating (living) with an intimate companion

Must be willing and able to uphold the image and leadership role of Jr. Miss Gila River throughout the twelve-month reign



Judging Criteria

- Demonstrate knowledge of the Community government, culture and history of the Akimel O'otham and Pee-Posh
- Personal Interview with pageant judges and impromptu sessions
- Extracurricular activities and Community involvement
- Pageant presentation Introduction
- Pageant presentation Traditional talent that is culturally appropriate and genuine three (3) minute time limit.
- Pageant presentation Business Attire
- Overall contestant poise and attitude throughout the pageant activities
- Overall communication skills throughout the pageant activities
